I understand that if I receive funding from the Faculty Housing Assistance Program and I choose to terminate my employment with San Diego State University prior to completion of two years of employment after the transfer of funds into escrow (unless the discontinuance of employment is the result of death, disability, or other similar unexpected causes beyond the control as determined by the appointing authority), I shall repay to the SDSU Research Foundation the following percentage of the amount received as reimbursement for housing:

100% - if employed less than 6 months

75% - if employed at least 6 months but less than 12 months

50% - if employed at least 12 months but less than 18 months

25% - if employed at least 18 months but less than 2 years

Frequently Asked Questions & Answers:

- Q: Am I eligible?
- A: You are eligible if you are or will be a tenure-track faculty member at SDSU in no later than the end of the 6th year of your appointment.
- Q: Can I use this for a second home purchase?
- A: No, this program is for first home purchases in San Diego or Imperial counties.
- Q: What can this funding go towards? Can I be paid directly?
- A: The payment may be used as part of a down payment, or for payment against points, or to cover closing costs. It may be used for you to qualify for and finance a first home purchase.
- Q: What happens if I did not find a home or close within my 90-day period?
- A: The application will expire and the funds set aside for your application will go back into the pool of funds. You must re-apply to be considered for the program.
- Q: If I just closed on a purchase of my first home, am I still eligible to receive this assistance?
- A: No, at the time of the FHAP application, you must be in 'active' search and/or in, escrow within the 90-day period of the application.
