

# Probationary Faculty

## Guide to Interfolio Periodic Evaluations

Probationary faculty in years 2, 4, and 5 are evaluated by their school or department each **Fall**. (Faculty in their first year may waive this evaluation in lieu of a mentoring meeting with their department chair or school director.) Interfolio allows you to assemble and share documents for evaluation using a digital platform. Please prepare and upload your materials by the deadline posted in the Periodic Evaluations timeline on the Faculty Advancement website. Your department coordinator will be able to assist you with many questions. A complete, step-by-step, downloadable Interfolio “Candidate’s Guide” is available on-line [here](#). ### Notifications

---

When a case has been created for you, you will receive an email with the subject line, “Interfolio Review, Promotion & Tenure: Case Available” from San Diego State University. The case link will expire in 30 days, so be sure to activate your account within that timeframe.



### Log-in

---

- You no longer need an Interfolio account to access cases. Go to [www.interfolio.com](http://www.interfolio.com) > Sign In > Partner Institution > select San Diego State University from the dropdown menu and you will be directed to Single Sign On. Log in with your SDSUId as the username, and password associated with your SDSUId.
- Problems logging in?
  - 1) Make sure you are using Google Chrome.
  - 2) Double-check with your department to make sure the correct email address was used to create your case.
  - 3) Double-check with your department to make sure that your email address was spelled correctly.
  - 4) Check your email Spam for email.



### Packet Requirements

---

- 📁 **Personnel Data Summary**  
(see PDS Form for full details, on Faculty Advancement website, under Tenured/Tenure-Track Faculty, Evaluations, Periodic Evaluation, Information for Candidates)
  - Teaching Effectiveness Statement
  - Professional Growth Statement
  - Service Statement
  - COVID Interruptions
  - Curriculum Vitae (see suggested template at Faculty Advancement website)
- 📁 **Prior Years’ Student Feedback Surveys** (formerly known as Student Evaluations) - in at least two courses each year of the evaluation period  
**\*Spring 2020 and Spring 2022 student feedback surveys are not required.**
- 📁 **Prior Years’ Periodic Evaluations and Performance Reviews** (if available)
- 📁 **Peer Observation** (if requested by department or candidate)



## Managing Materials

---

Collect your materials in one folder on your computer desktop.

- For paper materials, scan the documents into PDF format.
- For documents saved to your computer, the system will automatically convert any format to PDF format upon upload. Please note: if you upload your document in a non-PDF format such as Microsoft Word, the styling (headings, subtitles, etc), anchors, bookmarks, etc. will carry over to the “Reader View” and make it difficult for reviewers to navigate. We encourage converting these documents to PDF format before upload.
- **Document Naming Conventions.** Rename your documents so that the file names accurately indicate the contents:
  - Course Evaluations - Semester, Year, Course, Course Name (e.g., *Fall 2015 SOC 104 Introduction to Sociology*)
  - Reviewer Letters - Evaluator, Description - Candidate Last Name, First Initial (e.g., *Dean’s Recommendation Letter – Smith, J*)
  - Candidate Response Letters - Response to Evaluator, Description - Candidate Last Name, First Initial (e.g., *Response to Dean’s Recommendation Letter – Smith, J*)
- If you are the author of a published book, you may upload final galleys or a scan of the book in PDF format. If you would like to also submit a physical copy of the book, notify your College RTP representative. ## Student Feedback Surveys (formerly known as Student Evaluations)

---

**\*Faculty will be able to continue to download student feedback surveys from WebPortal until October 10, 2022. Thereafter, retrieval of legacy data will be forthcoming.**

Using Google Chrome, log-in to WebPortal:

- Choose "Faculty Evaluation Result."
- Under "Reports" in the left-hand menu, choose "By Section."
- Select the "Department," "Period," and "Instrument," choose the "Detail" radio button, and click "Next."
- Click the link for the particular section you want.
- Click "Print Combined Report." When the Print dialog box pops up, locate the "Destination" section in the menu on the left, and choose "Change." Under "Local Destinations," choose "Save as PDF." Choose "Save" in the upper-left hand corner. Name your file, indicate a save location, and choose "Save."



## Uploading Materials

---

- On your Interfolio dashboard, under “My Packet,” select “View.”
- Click “Instructions” in the upper right corner of the page to view instructions.
- Click “Work on Packet” to begin uploading materials.
- Use the “Add File” button to upload each item into the appropriate section (maximum file size 100 MB.)
- If you’ve added a file and receive a message that states “Creating PDF” for an extended amount of time, click on the Refresh button on your browser.
- Click the “Review & Submit” button to preview contents.
- Click “Submit” when you have successfully completed your uploads. **Do not submit your packet until ALL sections are complete.** After submission, you will not be able to edit the materials unless access is provided by your department coordinator.



## Viewing Shared Files

---

You will be notified by email when your evaluation letter is complete. Click the link in the email prompting you to log in to Interfolio, on your dashboard, under “Your Action Items” click on your name to view the packet; OR, click “Your

Packets” in the left hand navigation and select the case, open the “Shared Committee Files” tab of the case packet and files shared with you will appear listed.



## **Response/Rebuttal**

---

After viewing your shared files, if you are allowed to respond to the content of the file, you will see a link labeled "Send Response," and a due date for when your response is due (which is within 10 days following receipt of an evaluation). A [Sample Response/Rebuttal Letter](#) has been provided on the Faculty Advancement website for guidance. **Please do not attach any documents to your response/rebuttal letter**; any additional information or material must be submitted through the late-add process. Also note: the “Response Due” date in the top left corner of the materials reader. The system will not allow you to upload a response or rebuttal after 11:59 pm EST / 8:59 pm PST on that date, or change or preview your response. **As per direction from the CSU Chancellor’s Office, reviewers may only respond (within 10 days from the date of the response/rebuttal) if there is a change to their evaluation.**
